## Indicative 2010 Optional Subjects for Course Planning

Following requests from students and to assist you to plan your course, we are providing the information concerning planning of the optional program in 2010 and 2011.

At this stage, it is not possible to guarantee any subject offerings other than the Compulsory and quasi compulsory subjects.

As previously advised, it is anticipated that a full optional program will be offered in 2010 ie approximately 47-50 subjects covering a range of subject areas in line with the optional programs offered over previous years. The Law School has never guaranteed that any particular subject will offered but the lists below represent the Law School's planning based upon information currently available.

As previously advised, the optional program in 2011 is likely to be slightly smaller than in 2010, with an offering of around 37- 40 subjects. The program will cover the wide range of subject areas as in previous years although the numbers and names of subjects in any particular area may not be the same.

The Faculty's optional subject planning indicates that the first list of optional subjects will be offered unless some unexpected event occurs including unavailability of appropriate staff or insufficient enrolments. The subjects in the second list are likely to be offered but present planning does not permit us to indicate certainty. You will note that in some instances we have indicated that a subject in a particular field will be offered although we cannot indicate which particular subject. These have been listed in the second category. A range of subjects in the other categories will be offered but it is not possible to say which subjects at this stage.
